**Baseline year emissions:** 2020 was selected as our baseline year and the reporting conversion factor was BEIS 2020 using the GHG Protocol for Corporate Emission Reporting methodology. Refer to the Planet Mark Code of Practice for detailed information on the methodology and standards used in the preparation of this report. Restore use Planet Mark as the auditing body and have made contributions to the Eden Project and to Cool Earth's Asháninka community rainforest project as part of the Planet Mark Certification. .

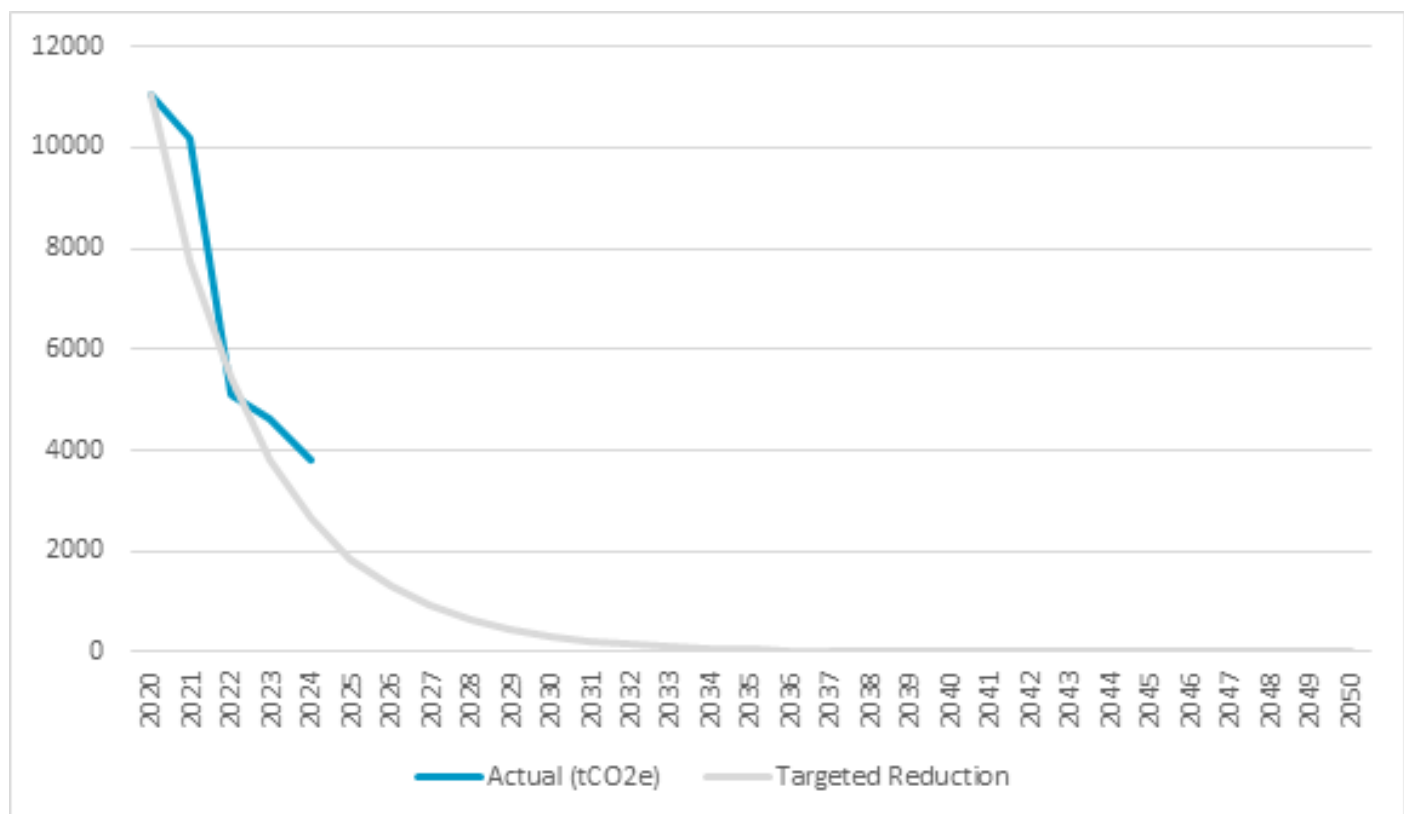




## Emissions Reduction Targets
